Access to the Kiwi Collection

Only NZSG Members can subscribe to the [Kiwi Collection](#). This is available online for \$50 per year or \$20 for a month.

What is the Kiwi Collection?

Our flagship research aid for finding family names from a diversity of sources including cemetery records, school admission records, probate indexes, NZSG Records Collection indexes, and various other records. This publication reflects the contribution of many thousands of hours of project work, by hundreds of members over the lifetime of the Society



NZSG Family Research Centre (FRC) & NZSG Library

The FRC and Library hold a wealth of research material including books, microfiche, microfilm, maps, computers, CDs and some sound recordings. Although strongest in New Zealand genealogy, family history and whakapapa, we also have specialist collections accumulated by our Interest Groups, including material covering the UK, Ireland, Europe, Australia, Africa, North America, Asia and the South Pacific. Our volunteers are on hand at all times to help with your research.

Here are just a few of our resources and services available to members:

- Access records on FamilySearch (we are an affiliate library)
- 13 computers for free research on Ancestry.com
- Pre-1856 New Zealand Marriage Records Collection
- Free access to Findmypast, The Genealogist.co.uk, and British Newspapers websites, Cornish Family History Database, Illegitimacies Database,
- Eight drawers of microfilms of some early NZ newspapers and Australian & New Zealand Shipping Passenger Records
- 28 drawers of microfiche including NZ vital records, cemetery collections, the IGI (International Genealogical Index) and other assorted records for New Zealand, Australia, England, Scotland, Ireland, Wales, Channel Islands and Isle of Man
- Access to over 500 CD-ROMS with data from NZ, Australia, UK, Ireland, Europe and the USA
- A large collection of laminated historical maps for England, Ireland and Scotland, including many large scale ordnance survey maps all available for photocopying
- Maps for New Zealand, Australia and other countries.

We also offer Scotland's People, a pay-per-view website. Our volunteers are on hand to help you narrow your search to make use of this as economical as possible.

When are we open? You will find [opening times and session charges](#) on our website. We are open most public holidays (except Good Friday and Christmas Day), but please check the website first or call the office (09 570 4248).

Reserving books and fiche: Please contact us at least three weeks before your visit. Materials may not always be available as we maintain a borrowing service.

Meeting room: The meeting room at the FRC is available for hire. Please contact the office for bookings and costs.

Some Library rules:

- Members can purchase a NZSG flash drive from reception to save downloaded files/images. Personal flash drives are not allowed.
- Only clear plastic bags may be brought into the library. Satchels, briefcases, laptop cases, handbags and coloured plastic bags are not allowed. This is for our mutual protection as research material and handbags could be stolen.
- We have free lockers for bags and other material.
- Only pencils may be used in the library. Pencils may be borrowed or purchased from reception. This is standard practice in archives and libraries worldwide.
- You can take your working notes into the library. Please ensure notebooks are labelled with your name. If you wish to take published reference works into the library, please label them clearly and show them to the librarian both when you enter and leave. The team leader on duty reserves the right to ask that large folders be left in a locker.
- You can take your laptop into the library, but the bag must be left in a locker. Laptop locks are recommended. WiFi is available - please ask for the access code.

Research from home? An email query can be sent to ResearchService@genealogy.org.nz. FRC Volunteers will do look-ups on your behalf and produce suggested avenues to explore to find an elusive ancestor or link. (See page 7 for more details.)

Books and microfiche from the NZSG Library may be borrowed and can be posted anywhere in New Zealand.

You can log into the NZSG website and gain access to the Gale collection of searchable On-Line UK and USA Newspapers and the UK National Archives online databases (Discovery) for no extra charge. (Refer to page 9).

A request sent to the office holders responsible for Pedigrees Collection, First Families Collection, Pre-1856 New Zealand Marriage Records Collection or the Certificates Collection seeking information held about specific names you are researching may also yield useful results. (See page 7 for more details.)

Postal service: Members resident in New Zealand can use our postal borrowing service. Up to four items may be borrowed for up to four weeks. (Refer to details of cost on the website.)

Branches

We have a large network of branches across the North Island and South Island. Branches provide social interaction as well as being a huge source of research expertise. They can provide information on local events, education, meetings and links to the wider genealogy community. Member-only record collections

These collections contain material either submitted by members or collected by our office holders. Log on to the Members Area of the website to find out more or read 'Where to write' in The New Zealand Genealogist. There is no charge for these services. An index to these collections is published in the [NZSG Kiwi Collection](#).

[NZSG Pedigree Collection](#)

This is a collection of pedigree charts sent in by members. Each surname on the chart is entered into a computer index. Surnames may be cross-referenced to pedigrees of other members. Members are encouraged to submit their first pedigree sheet when they join and to add to this later in their research. Members may also request information from the collection.

[NZSG Pre-1856 New Zealand Marriage Records Collection](#)

This is an Index of New Zealand marriages which took place before compulsory civil registration began on 1 January 1856. Entries have been taken from civil registration entries, church records, newspaper marriage notices, family and social history publications, Maori mission records, Bible entries, ministers' diary and journal entries, and submissions from NZSG members.

This service can help match brides and grooms, date and place of marriage and a source where further information can be found. Members are invited to contribute to this collection if they have information about a marriage which took place before 1 January 1856 if it does not appear to be in this collection.

[NZSG Certificates Collection](#)

The Collection is a repository for Birth, Death and Marriage certificates and miscellaneous documents of any kind, donated by members, whether related to their research or not, for sharing with other members. Members are asked to submit paper copies of their certificates and other documents for inclusion. Members may request a search of the index in this collection and order copies of any documents of interest.

[NZSG First Families Collection](#)

This is a collection of information about families where partners were married in New Zealand before 1901 or where the family emigrated to New Zealand before 1901. The collection is an index from family record sheets contributed by members of the NZSG.

Each family record sheet includes the names of three generations and their spouses (where these are known). The record is based on the first couple of any family unit living in New Zealand before 1901, and it includes their children. It also includes their parents who may not have come to New Zealand, thus bridging the gap between New Zealand and the country of origin.

[Griffis Illegitimacies Collection](#)

This collection is a name-searchable database involving illegitimate births in New Zealand between 1877 and 1950 that were available on Public Records either at local Court Houses or National Archives. Virtually all of these records have now been transferred to Archives New Zealand.

The database includes details of the Child (if named), the Mother and the Father, the location of the event, the record type and repository. Successful results are printed into a formatted report that can be saved or printed. Query results provide basic information only – researchers are encouraged to go back to the original source record for fuller details.

[School Records](#)

School Admission, Progress and Withdrawal Registers can assist in putting families together, placing them within communities and tracing their movements from place to place. An index is published in the NZSG Kiwi Collection.

[New Zealand Cemeteries](#)

Since 1967 The New Zealand Society of Genealogists has produced cemetery transcriptions for approximately 1400 cemeteries nationwide. Dates range from 1812 through to 2017. Most municipal cemeteries are included, but a significant proportion of this collection includes private cemeteries, Maori Urupa and remote burial locations.

[Funeral Service Sheets](#)

With the introduction of the Privacy Act in 1993, more recent information about our family connections has become increasingly difficult to find. With this in mind, in late 2016 the Society set up a new national project to collect and index Funeral Service Sheets. Funeral Service Sheets generally include the date of birth, date of death, and have photographs, not only of the deceased themselves, but sometimes of their family.

An index of the NZSG Funeral Service Sheet Collection is published in the NZSG Kiwi Collection and steers researchers to where they may obtain a copy.

[Obituaries](#)

Obituaries typically include the date of death and a brief biography of a deceased person's life. Apart from being a commentary on the person's life and legacy, they are often a window into the social norms of the time.

The NZSG Obituaries Collection includes contributions from members nationwide from sources such as national and regional newspapers, club newsletters and periodicals. An Index of this collection is published in the Kiwi Collection

Members' interests

You can use this online database to find others researching the same families. Surname interests can be [added to our website](#). There are no restrictions on how many you may enter. You can [search](#) names entered by other members.

Member-only research services

These services are available to members to help them with both New Zealand and overseas research. Refer to the latest edition of The New Zealand Genealogist or our website for current contact details.

Research service: The Research Service team offer look-ups in the indexed resources of our Library and can offer advice to further your research. Consult the online library catalogue to find out what is available for your area of interest. The Research service can be contacted by email: ResearchService@genealogy.org.nz

Government Gazettes: The Library has a digitised searchable version of the New Zealand Government Gazettes 1840-2005. Members can contact Research Services to arrange look-ups: ResearchService@genealogy.org.nz

Land Research Service: This service offers advice and assistance in researching New Zealand land records. The Land Research Officer can help locate parcels of land where your ancestors lived and provide advice on purchasing records of title. In most instances, we can provide deposited or survey office plans and where required provide advice on using Deeds Indexes and Registers. To use this service go to [our website](#).

Online services/databases

[Gale Historical Newspaper Collection](#): This website works in a similar way to New Zealand's PapersPast website. These United Kingdom and United States of America newspapers and periodicals cover more than 300 years of local and national news. Members can search, then save or print images.

[National Archives \(UK\) Discovery](#): Search from home through the Discovery service for National Archives documents such as wills (back to the 14th century) and military records which you can download at no charge.

[NZSG Digital Archive for Family History](#): This offers a free archival service to ensure genealogical files will be retained in the Archive for the use of descendants.

While members are always encouraged to publish a narrative family history from their research (in book or digital format), they should also make a copy of their current database material and submit to the archive for safe storage.

When the narrative family history work is ready for submission to the Archive, the submission should include an index of the people named in the narrative. From this, a searchable index is created for all members to search on-line.

FamilySearch Affiliate Libraries

FamilySearch have digitised over 2 million rolls of microfilm. Many of these are only available at LDS Affiliate Libraries. The NZSG is happy to partner with FamilySearch to run Affiliate Libraries at the FRC, the National Library in Wellington and at our Canterbury Branch in Christchurch.
